RREACH's GProCommission is a decade-long initiative dedicated to connecting, uniting and strengthening 100,000 fine, young lead pastors in emerging economies - primarily in Asia, Africa and Latin America. The goal is to provide younger lead pastors critical ministry training and peer relationships that allow them to minister more effectively with churches and non-believing communities, and to do so in such a way that allows the Gospel a fair and serious hearing. RREACH believes that sound proclamation of God's Word is crucial to fulfilling the Great Commission of the Lord Jesus Christ. The GProCommission consists of the Dallas Global Proclamation Academy (GPA), National GPAs, the Global Proclamation Congress for Pastoral Trainers, held June, 2016, and an intensive four year follow-up effort.

Form 990, Part VI, Section B, 11B; Review of Form 990. Each year the completed Form 990 and all attachments are presented to the Board of Directors for their review and consideration prior to being filed with the IRS.

Form 990, Part VI, Section B, 12c; Conflict of interest. All members of the Board of Directors annually disclose any related party transactions for review to the Board Chair and are maintained with the meeting minutes. In addition, the Director of Operations monitors all business relationships for possible conflicts of interest throughout the year. In cases of a possible conflict, the Director of Operations obtains independent bids for the work to be performed. The bids are reported to the Audit Committee for its review, determination of what is in the best interest of the organization, and recommendation to the Board of Directors. Related party transactions are disclosed in the audited financial statements.

Form 990, Part VI, Section B, 15a, b; Executive compensation. Each year a detailed listing of compensation, benefits and other remuneration of the President is presented to the Board of Directors for its review, consideration and approval.

Salary survey documentation and market standards are also presented periodically for context. The Board of Directors annually approves the overall amount of compensation for the President prior to the start of the calendar year.

Due to greater intensity and time commitment necessary to convene and oversee the implementation of the 2016 Global Proclamation Congress for Pastoral Trainers, the RREACH Board of Directors increased the President's compensation effective mid 2012. This adjustment is to be reviewed after the GProCongress has concluded.

The organization makes its Form 1023, Form 990 (3 most recent years), and audited financial statements available to the general public upon request.
