The goal is to provide younger lead pastors critical ministry training and peer relationships that allow them to minister more effectively with churches and non-believing communities, and to do so in such a way that allows the Gospel a fair and serious hearing. RREACH believes that sound proclamation of God's Word is crucial to fulfilling the Great Commission of the Lord Jesus Christ. The GProCommission consists of the Dallas Global Proclamation Academy (GPA), National GPAs, the Global Proclamation Congress for Pastoral Trainers, held June, 2016, and an intensive four year follow-up effort.

The bids are reported to the Audit Committee for its review, determination of what is in the best interest of the organization, and recommendation to the Board of Directors. Related party transactions are disclosed in the audited financial statements.

Each year compensation, benefits and other remuneration to the President is presented to the Board of Directors for its review, consideration and approval. Salary survey documentation and market standards are also presented periodically for context.
