The GProCommission consists of the Dallas Global Proclamation Academy (GPA), National GPAs, Regional and Global Proclamation Congresses for Pastoral Trainers, and an intensive GProCongress follow-up effort.

In addition, the VP of Operations monitors all business relationships for possible conflicts of interest throughout the year. The bids are reported to the Audit Committee for its review, determination of what is in the best interest of the organization, and recommendation to the Board of Directors. Related party transactions are disclosed in the Board minutes and audited financial statements.

Each year compensation, benefits and other remuneration to the President are presented to the Board of Directors for its review, consideration and approval. Salary survey documentation and market standards are also presented periodically for context.
