The goal is to provide these pastors critical ministry training and peer relationships that allow them to minister more effectively with churches and non-believing communities, and to do so in such a way that allows the Gospel a fair and serious hearing. RREACH believes that sound proclamation of God's Word is crucial to fulfilling the Great Commission of the Lord Jesus Christ. The GProCommission consists of the Dallas Global Proclamation Academy, National Proclamation Academies, Regional and Global Proclamation Congresses for Pastoral Trainers, an intensive follow-up efforts, and establishing local pastor training communities.

Schedule D, Part X, Line 2 - RREACH is under a non-cancelable operating lease for office space that expires in 2027. The accounting standard ASC 2016-02, Leases (Topic 842) requires RREACH (the lessee) to recognize an operating lease on the statement of financial position as lease right-of-use ("ROU") asset and a corresponding lease liability. Periodic operating lease costs are allocated with expenses on the statements of activities and functional expenses. The ROU asset is measured based upon the minimum future payments remaining on the lease, which totaled approximately \$165,438 and \$133,490, respectively, at December 31, 2024 and 2023. The operating lease liability is carried at the same value as the ROU asset, and each subsequent year, the ROU asset and lease liability are reduced equally by the annual lease payments. A discount rate was not used since it was determined not to materially impact these calculations. For each of the years ended December 31, 2024 and 2023, operating lease expense was approximately \$55,972 and \$43,000, respectively.
